We are pleased and privileged to manage a portion of the scholarship funds made available by the Dorothy Ratermann Charitable Remainder Unitrust and the Wilhelmine Ratermann Charitable Remainder Unitrust. **SCHOLARSHIP PURPOSE:**

The scholarships will be awarded to high school seniors enrolling as full-time students in an accredited institution of higher learning, e.g., colleges or vocational or technical schools. The purpose of the scholarships is to jump start a student’s higher academic journey, and thus are provided for the freshman year only.

The scholarships are intended to benefit students in “financial limbo.” Specifically, this refers to those whose families have midlevel incomes, and thus earn too little to pay for college tuition outright, but earn too much to qualify for need-based scholarships.

The scholarships will give priority to students who are not competitive for other types of substantive scholarships. This includes those who do not have grades high enough, or skills and talents developed enough, to obtain other scholarships because, for example:

- Their grades, though acceptable, are not high enough to be competitive for scholastic-based scholarships;
- They have not excelled in sports to the level at which they would be competitive for sports-based scholarships, or

- They have not excelled in music to the point where they are competitive for music-based scholarships.

The scholarship will provide financial support to students who:

- Show academic promise,
- Participate in community and Church activities at a level which portends future benefit to society and the Church,
- Exhibit enthusiasm, ambition and abilities indicative of a prudent use of scholarship funds, and
- Exhibit need for financial assistance for college or higher education.

### WHO IS ELIGIBLE FOR THE SCHOLARSHIP?

First consideration will be given to students who are registered and active members of St. Francis of Assisi Parish, Aviston, IL. Secondary consideration will be given to any other students in the Aviston area only after all primary applicants have been considered.

Applicants are *ineligible* if they receive financial assistance in any form from either the Dorothy or the Wilhelmine Ratermann Charitable Remainder Unitrust. **Scholarships are only available for tuition costs. The Trust does not allow scholarships to be awarded for room and board, books, etc.** so students without tuition obligations due to family employment benefits, grants or other scholarships have no eligibility.

Applicants must have an acceptable academic record, defined as a grade point average (GPA) of 2.0 or above on a 4-point scale, i.e., a “C” average, hereinafter referred to as “acceptable grades.”

### APPLICATION REQUIREMENTS

The application package must include the following:

- \_\_\_ The attached application form, filled in completely.
- \_\_\_ Three letters of recommendation from three different adults who are not close family members, for example, not parents, grandparents, siblings, aunts, uncles or first cousins. These letters will consist of one each from:
  - A teacher or school administrator
  - An adult leader of the parish youth ministry
  - Another adult of the community

Letters must be attached as part of the application package, and not mailed separately. Letters are to be addressed to:

- \_\_\_ Transcripts of all school work undertaken to date, including college entrance exam scores (ACT or SAT)
- \_\_\_ An essay written by the student. On separate paper, using 400-600 words, explain your educational and professional aspirations in life and how the scholarship would help you attain those goals.

Typewritten products are preferred. Handwritten applications are acceptable but must be legible.

All application packages become property of the scholarship board and will be kept confidential. Likewise, all deliberations of the scholarship board are confidential. Decisions of the board are final and cannot be appealed.

**DEADLINE:**

Applications for a given academic year must be received or postmarked by 1 Mar of that year. For example, applications for the 2008-2009 academic year must be received by 1 Mar 08. Scholarship recipients will be announced on or about 1 May.

**SCHOLARSHIP AMOUNTS AND FUNDS MANAGEMENT:**

Scholarship amounts will vary depending on student need, funds availability and other factors. An award of \$2,000 is not an unreasonable expectation.

Funds may be used only for tuition and will be paid directly to an accredited institution of higher learning, e.g., colleges or vocational or technical schools. No funds will be dispersed directly to a student or made available for non-tuition costs such as books, lab fees, room and board or other expenses. Funds will be dispersed in two payments, one/half of the total scholarship at the beginning of the first semester, and the remaining half at the beginning of the second semester. The parish scholarship board will require the student to provide proof of acceptable grades, with no failed courses, as well as proof of enrollment for a second semester, before second-semester funds will be distributed to the college or institution.
